Requirements

Data regarding participation in Student Early Intervening Services (EIS), Homeless students, Title I services, Dual Language, Students Earning Credentials, Academic Enrichment and 21st Century CLC, Distance Learning, etc. are submitted using this submission to RIDE. Title I services apply only those LEAs which contain Title I Targeted Assistance Schools. Dates for submitting the program data vary by program type. Specific submission requirements are defined in each program's section of this document.

Changes for 2025-26 School Year

Beginning in 2025-26, the RIDE source of record for foster care data will be DCYF so RIDE will no longer collect the 'Child in foster care' program code from LEAs.

Submission Process

Program data can be submitted through eRIDE (<u>www.eride.ri.gov</u>) using the Enrollment Census application or through the Automated Data Transfer (ADT) agent. The submission type for submitting *Program* data is Program Core.

Validations

DISTCODE – This field must be a valid LEA in the RIDE master directory and must also be the district associated with the user that is submitting the data.

SCHCODE – This field must be a valid school in the RIDE master directory and must also be a school within the DISTCODE. Additionally this school must be participating in a Title I Targeted Assistance (TAS) program.

SASID – This field must be a valid student id in the RIDE student master directory. This field is also validated against the enrollment data submission to ensure that the student is enrolled in the school.

PROGRAM_SDATE – When required, this field must be a valid date between the first and last day of school for the SCHCODE.

PROGRAM_EDATE – When required, this field must be a valid date between the first and last day of school for the SCHCODE.

Title I Program Data

About

Submission of Title I services are applicable to LEAs which contain schools that are participating in a Title I Targeted Assistance (TAS) program or Local Neglected Program (NEG). Please note that schools are identified as participants in a Title I program on a yearly basis and this is communicated to LEAs by RIDE. Tracking and reporting of either set of EIS data is a federal requirement.

The *EIS* data submission is a continuing submission in the Program Core that LEAs continue to be required to submit. LEAs are encouraged to submit this data throughout the year.

Academic Enrichment Program Data

About

Academic Enrichment program data includes student level data about students who are participating in an academic enrichment program. The goal of the College Crusade of Rhode Island is to reduce high school dropout rates and increase educational and career success for low-income urban youth. The Crusade serves approximately 3,500 students from Rhode Island's most economically disadvantaged families in Providence, Pawtucket, Central Falls, Woonsocket, and Cranston. The Rhode Island College Upward Bound Program is designed to instill in low-income, potential first-generation college students the skills and motivation to complete high school and to enter and graduate from college. The goal of Upward Bound is to increase the high school and college graduation rates of program participants.

Requirements

Districts are required to submit academic enrichment program data if they have students in their district who is participating in any of the following programs: College Crusade or Upward Bound.
