#### **About**

The Career and Technical Education data collection includes specific information regarding all RIDE approved or provisionally approved CTE programs. The data includes CTE program and student level information that will be used for reporting requirements including RIDE accountability measures. Some data elements will need the input of the CTE director or instructor as some program and student level has not historically been tracked. ## Requirements

All LEAs which have a RIDE approved or provisionally approved CTE program must submit this collection. The CTE-Programs and CTE-Courses submissions must be submitted to RIDE when the school year begins and kept up to date throughout the school year to reflect the CTE programs and courses that are being offered in your LEA/School. The CTE-Programs and CTE-Courses are required for all LEAs/Schools that offer RIDE approved or provisionally approved CTE programs. The CTE-StudentsInProgram must be submitted in the beginning of school year, and kept up to date throughout the school year. The end of the year student information must reflect the students who enrolled and completed their specific course. The CTE-ApprenticeshipPrograms, CTE-RecognizedCredentialsEarned and CTE-PostSecCredit submissions must be submitted as the applicable data becomes available for each CTE student in your LEA/School.

Students become concentrators after completing at least two courses in a program of study. Typically the program of study requires a sequence of 3 or 4 full-year courses. In some districts, the full year course in the sequence is broken up into multiple semesters. It is up to the program leaders to delineate which courses make up the required 3 or 4 part full sequence. For example, a 3-part program or sequence might be split into 6 half-year courses. A student then would become a concentrator only after completing the 4th half-year course that can be thought of as the second full part of the program. In this example, the value reported here would be 4. In most cases however this will be 2.
