

# Rhode Island Department of Education Data Collection Specifications – Charter School Applicant Report



Last Updated on March 21, 2025

## About

*Charter School Applicant Report* is the application used by RIDE to collect information regarding individuals that apply for enrollment to a charter school.

## Requirements

Each year, after collecting applications from prospective students and managing enrollment lotteries, Rhode Island charter schools must submit their application data to RIDE. The submission provides data on all students who applied to the school, and whether they are offered a seat, a waitlist spot, or were invalid applicants. Although this data is collected during the 2024-25 school year, the school year for which the lottery applicant data is being submitted is the **2025-26 school year**.

## Changes for April 2025 Submission

For this year's submission, a new field named SCHOOLNAME has been added. In most cases, this would be the school name associated with the school code. However, for schools with multiple programs/tracks, this would be the school name plus the identifying program/track name.

## Submission Process

*Charter School Applicant* Data can be submitted through RIDE's portal (<https://portal.ride.ri.gov>) using the Charter School Applicant Report application.

#### ***Validations***

***DISTCODE*** – This field must be a valid LEA in the RIDE master directory and must also be the district associated with the user that is submitting the data.

***SCHCODE*** – This field must be a valid school in the RIDE master directory and must also be a school within the DISTCODE. The school code provided must be a charter school.

***GRADE*** – Must be a valid grade (PK, PF, KF, KG, 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12)

***ADDRESS\_D\_STATE*** – Charter school applicants must be residents of RI so the only acceptable value is RI.

***ADDRESS\_D\_ZIP*** – This field must be exactly 5 characters and include only numbers.

***ADDRESS\_D\_CITY*** – This field must be a valid city/town in the state of Rhode Island.

***ADDRESS\_D\_CITY/ADDRESS\_D\_ZIP*** – The zip code provided must be associated with the city/town and state reported.

***DOB*** – Must be a valid date format and this date must be a date earlier than today. The date of birth must be at least 3 years from the date of reporting.

***YEAR*** – The YEAR must be in a school year format (ex: 2015-16) and must be the next school year.

***SIBLINGCURR*** – Must be Y or N

*SIBLINGCONCURR* – Must be Y or N

*SCHOOLFOUNDER* – Must be Y or N

*SEATOFFERED* – Must be Y or N

*WAITLISTED* – Must be Y or N

*INVALIDAPPLICANT* – Must be Y or N

*PERMISSION* – Must be Y or N

*SEATOFFERED/WAITLISTED /INVALIDAPPLICANT* – Only 1 of these values can be Y.

*SEATOFFERED/WAITLISTED /INVALIDAPPLICANT* – One of these values must be Y.
