

# Rhode Island Department of Education Data Collection Specifications – Attendance



Last Updated on June 2, 2022

## About

*Attendance* data includes information for every school day for every student describing the student’s attendance in a school. This collection collects days of attendance, days of absence, days of tardiness, and days of early dismissal.

## Requirements

The *Attendance* data submission is an existing submission that LEAs have been submitting to RIDE since the 2008-09 school year on a daily basis.

## Changes for 2022-23 School Year

In the past, RIDE required only the absent, tardy and early dismissal codes to be reported. Beginning in the 2022-23 school year, present codes are also required so every student should have an attendance record for each day.

## Submission Process

*Attendance* data can be submitted through eRIDE ([www.eride.ri.gov](http://www.eride.ri.gov)) using the Enrollment Census application or through the Automated Data Transfer (ADT) agent. *Attendance* is a submission type within the Enrollment Census application.

### ***Validations***

*DISTCODE* – This field must be a valid LEA in the RIDE master directory and must also be the district associated with the user that is submitting the data.

*SCHCODE* – This field must be a valid school in the RIDE master directory and must also be a school within the *DISTCODE*.

*SASID* – This field must be a valid *SASID* in the RIDE student master directory.

*DISTCODE/SCHCODE/SASID* – The student (*SASID*) must be enrolled in the current enrollment submission in the school reported in Attendance as *SCHCODE*.

*ATTEND\_DATE* – A student can have 1 *TARDY* and 1 *EARLY DISMISSAL* record. In all other cases, the *ATTEND\_DATE* can only occur once per *SASID*. In addition, this field must be a valid date between the first and last day of school for the *SCHCODE*.
