The Department of Human Services and the Rhode Island Department of Education will be holding several forums in July and August to solicit feedback on the first draft of the Core Competencies for Early Childhood Educators in Rhode Island.

This document is designed for several purposes including:

- Supporting teacher's individual professional development efforts;
- Assisting program administrators with articulating teacher job expectations and designing evaluation processes;
- Serving as a framework for Rhode Island's early education leaders for developing a state-wide professional development system;
- Guiding higher education and professional development providers in the development of curricula and training opportunities, and;
- Helping families to identify quality early education settings for their children.

The goal of the forums is to gather feedback from stakeholders that will ensure that the core competencies document can be used effectively for these purposes.
